

MCM Comic Con London May 2024 Hope and Homes For Children Free Prize Draw

Terms and Conditions

1. Who are we?

- The **MCM Comic Con London May 2024 Hope and Homes For Children Live Tickets Free Prize Draw** (referred to in these terms and conditions as “**the Prize Draw**”) is offered to you by **Reed Exhibitions Limited**, of Gateway House, 28 The Quadrant, Richmond, Surrey TW9 1DN (hereinafter also known as “**we**” or “**us**”).
- We are the organiser of the **MCM Comic Con** events, including MCM Comic Con London May 2024 taking place at ExCel Centre, London from 24th to 26th May 2024 (referred to in these Terms and Conditions as “**the Event**”), and the owner and controller of the website, www.mcmcomiccon.com (“**the Website**”).
- **Hope and Homes For Children (“Hope and Homes”)** is a global registered charity which is the charity partner for MCM Comic Con events in 2024, especially the Event.
- The Prize Draw being run by us, in conjunction with Hope and Homes, is for two (2) prizes of one weekend ticket for the Event, i.e. tickets covering all three (3) days of the Event (“**the Prize**”).

2. What terms, conditions and rules apply to the Competition?

- These Terms and Conditions apply to the Prize Draw.
- You will be deemed to have accepted these Terms and Conditions and be bound by them upon entering the Prize Draw, which you do so merely by responding to a post issued on our and Hope and Homes’ social media platforms and sites between the Opening Date (as defined below) and the Closing Date (as defined below) and telling us and Hope and Homes what “home” means to you.

- The Prize Draw will be open for you to post your response, along with your email address, at any time between 10:00 hours BST on Friday 3rd May 2024 (“**the Opening Date**”) and 23:59 hours BST on Monday 17th May 2024 (“**the Closing Date**”). Anyone who posts a response to the post issued by us and Hope and Homes shall be deemed to an entrant
- If you are in breach of these Terms and Conditions, you may be excluded from access to the Prize Draw.
- Entry into the Prize Draw is only as outlined above, for each of the two (2) x MCM Comic Con Weekend Tickets for the Event only.
- Unfortunately, the following persons are excluded from entering the Prize Draw and their entries will not be considered:
 - (a) employees of Reed Exhibitions Limited and any associated company of Reed Exhibitions Limited;
 - (b) employees and contractors of the ExCeL Centre, London; and
 - (c) any person directly or indirectly involved in the running of the Prize Draw;

3. Prize Draw Guidelines

- You will only be entitled to submit one entry for the Prize Draw. Any duplicate entries will be removed.
- The Prize Draw is open for the period between the Opening Date and the Closing Date. Any entries received outside this period will not be accepted.
- We may, at our discretion, alter, amend, suspend or withdraw the Prize Draw without prior notice. We will not change the terms unless forced to do so by unavoidable circumstances outside of our control. Any such changes will be indicated on the Website as well as on Home and Homes’ website, www.hopeandhomes.org, and it is your responsibility to check for any changes.

Prize Details

- There are two (2) Prizes, each for one (1) weekend ticket, offering entry and access to the Event at the ExCeL Centre, London, for each of Friday 24th May, Saturday 25th May and Sunday 26th May 2024.
- The Prize(s) cannot be exchanged for cash or any other equivalent nor sold or transferred to a third party without our formal prior approval, such approval not to be unreasonably withheld or delayed.

4. How much will it cost me to enter the Prize Draw?

Entry is free of charge. No purchase is necessary and there is no additional applicable condition, but, if you are a Winner, you will be responsible for any travel and other related costs to attend the Event.

5. Selection of Winner(s)

- On **Tuesday 7th May 2024**, two (2) entrants will be drawn at random from the Prize Draw entries received by us and Hope and Homes from all qualifying entrants by the time of the Closing Date and each drawn entrant will become a winner in accordance with these Terms and Conditions (“**the Winner(s)**”),
- If you are a Winner, we reserve the right to verify your eligibility and to check or validate your identity. If you have been asked for proof of your identity and/or your eligibility, your failure to provide such proof within a reasonable period of time could result in your disqualification from the Prize Draw and a fresh Winner selected. All personal details and information you supply must be truthful and accurate.
- Each Winner will be notified via email. In order to redeem a Prize, each Winner will be required to send their acceptance to us via email, so that the Prize can be despatched to the Winner.
- If you are a Winner, we may ask your permission to take your photograph or we may ask you to provide a photograph. Subject to receiving your consent, you authorise us to use such image and likeness of you in any media for our own promotional purposes only.
- We must either publish or make available information that indicates that a valid Prize Draw has taken place. To comply with this obligation, we will send the surname and county of each of the Winners of the Prizes to anyone who emails us or writes to the address set out in paragraph 1 (enclosing a self-addressed envelope) within one month after the Prize Draw is drawn. If you object to your surname and county being published or made available, please contact us at the email address at the top of these Terms and Conditions. In such circumstances, you should note that we must still provide the information and the Winners’ details to the Advertising Standards Authority, on request.

a. How will we use your personal details?

We will only use your personal details to operate the Prize Draw to verify your identity and eligibility, to notify you if you are a Winner and to use your surname and county as well as, with your consent, your photograph, for our and Hope and Homes’ promotional purposes only.

b. How far are we liable or responsible to you?

Nothing in these Terms and Conditions removes or limits our liability for fraud, for death or personal injury caused by our negligence or for any liability which cannot be limited or excluded by law. These Terms and Conditions also do not affect the rights that are granted to you as a consumer by law. Otherwise, we will not be liable to you for any matter relating to the Prize Draw offered by us. We will also not be liable to you if you suffer loss or inconvenience because of the failures of persons or systems that we do not directly control – for example, mobile phone network operators, internet service providers, postal services, software providers and telephone traffic handlers.

c. The legal position of these terms and condition

These Terms and Conditions form a legally binding agreement between you and us. We reserve the right to change them and update them from time to time but, if we do so, we will post the changes on the Website.

The Prize Draw is run and organised by us strictly in accordance with the laws of England and Wales. These terms and conditions shall be governed by the laws of England and Wales and the parties submit to the exclusive jurisdiction of the courts of England.
